Agenda

1. Call to order by Mayor Miller @ 6:30pm.
2. Pledge of Allegiance led by Councilman Barnett.
3. Roll Call; Mayor Miller, Mayor Pro-Tem Spahlinger, Councilman Haag, Councilman Barnett, Councilwoman Hanson, & Councilman Rottino were all present.
4. Mayor Pro-Tem Spahlinger made a motion to approve Minutes: Regular Meeting 09/19/2023. Seconded by Councilwoman Hanson. Motion carried 5/0.
5. Councilwoman Hanson made a motion to approve Consent Agenda Items “A” thru “E”; Monthly Activity Reports for September 2023 as presented: (A) Financial and Expenditure; (B) Police; (C) Municipal Court; (D) Streets; (E) Equipment. Seconded by Councilman Barnett. Motion carried 5/0. Mayor Miller suggested a workshop meeting with council to explain what all the numbers in the budget represent.
6. Fire Department report for September 2023 read by Councilman Rottino.
7. Citizen Comments: Citizens wishing to speak must sign up to do so (3 Minute Maximum) – NONE at this time.
8. Councilwoman Hanson made a motion to approve Replat for Wiseman Lots 128 & 129 in the Southwood Shores Subdivision. Seconded by Mayor Pro-Tem Spahlinger. Motion carried 5/0.
9. Mayor Pro-Tem Spahlinger made a motion to approve Business permit renewal does not have to go in front of council for approval for 2024. Seconded by Councilwoman Hanson. Motion carried 5/0. Mayor Pro-Tem Spahlinger made a suggestion by 1/1/2024 that Code Enforcement verify Business Permits in City of Payne Springs, and enforce Ordinance 2019-03-19 that there are not to be Businesses conducted in Subdivisions.
10. Mayor Pro-Tem Spahlinger made a motion to approve moving forward with an Interlocal Agreement with Henderson County to Chip Seal Double Bridge and Frazier Lane. Seconded by Councilwoman Hanson. Motion carried 5/0.


A meeting that is “open to the public”, pursuant to the Open Meetings Act, is one that the public is permitted to attend. The act does not entitle the public to choose the items to be discussed or to speak about items on the agenda. If the City Council, during the course of the meeting covered by this notice, should determine that an executive session is required, then such executive session, as authorized by the Texas Open Meetings Act, Texas Government Code, Section 551.001 et seq., will be held by the Council at the date, hour and place given in this notice, concerning but not limited to the following sections and purposes of the Act: 551.071 Private consultation with the city’s attorney; 551.072 Deliberations about Real Property; or, 551.074 Discussing personnel or to hear complaints against personnel. Should any final action, final decision or final vote be required in the opinion of the City Council with regard to any matter considered in such executive session, then the final action, final decision or final vote shall be in the open meeting covered by this Notice upon the reconvening of the public meeting.

“Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the citizens comment section of the meeting or at the time the agenda item is called for discussion by the mayor. Speakers must sign up with the City Secretary to speak and shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Criticism of city employees or staff is prohibited. Those wishing to

address the Council regarding an item not on the agenda must be a citizen, property owner or business owner of Payne Springs. Comments on such non-agenda items shall be limited to three minutes. The Council will not comment on items not on the agenda; however, the Council may refer the item to city staff for research, resolution or referral of the matter to the Council as a future agenda item.”
