DESCRIPTION OF AREA PROPOSED TO BE ANNEXED INTO THE BAST CEDAR CREEK FRESH WATER SUPPLY DISTRICT HENDERSON COUNTY, TEXAS

Beginning in the center of Peacefull Woods Road at the intersection of Water Oak Road in the Oak Shores Estates Subdivision, thence easterly along center line of Peacefull Woods Road 1,140' to a point for corner at the southeast corner of Oak Shores Estates.

THENCE N 00° 03' E along the East boundary line of said subdivision approximately 1,130' to a point for corner.

THENCE N 30° 27' W approximately 115.2' to a corner.

THENCE N 12° 09' E approximately 75.3' to a corner.

THENCE N 16° 51' E approximately 95.4' to a corner.

THENCE N 70° 41' W approximately 140' to a corner.

- THENCE N 10° 00' W approximately 2,800' to a point on the existing boundary line of East Cedar Creek FWSD. This point being a corner described in H.B. No. 2165.
- THENCE S 51° 00' W 12,500' along the South boundary line of the East Cedar Creek FWSD to a point for corner.
- THENCE in a westerly direction approximately 3,000' along the South boundary line of East Cedar Creek FWSD to a point for corner.
- THENCE in a southerly direction approximately 9,200' to a point for corner.

THENCE S 43° 04' E approximately 17,984' to a point for corner.

THENCE in an easterly direction approximately 3,119' to a point for corner.

THENCE N 15° 00' W approximately 5,650' to a point for corner.

- THENCE in a northerly direction approximately 13,450' to a point for corner.
- THENCE in a westerly direction approximately 2,000' to a point for corner.

THENCE in a northerly direction approximately 2,500' to a point for corner in the center of CR 2529.

THENCE in an easterly direction approximately 2,000' along the center line of CR 2529 to a point for corner.

- THENCE in a northerly direction approximately 2,150' to a point for corner.
- THENCE in a westerly direction approximately 2,150' to a point for corner.
- THENCE in a northerly direction approximately 2,300' to a point for corner in the center of Peacefull Woods Road.
- THENCE in an easterly direction along the center line of Peacefull Woods Road appoximately 300' to a point for corner.
- THENCE in a northerly direction along the center line of Peacefull Woods Road approximately 150' to a point for corner.
- THENCE in an easterly direction along the center line of Peacefull Woods Road approximately 175' to a point of beginning and containing 6,170 acres more or less.
