REGULAR MEETING MINUTES FOR THE CITY OF PAYNE SPRING, TEXAS July 17, 2018

Mayor Rodney Renberg called the meeting to order at 6:30 PM.

Mayor Rodney Renberg invited everyone to stand for the Pledge of Allegiance, led by Dick Hoffman.

Mayor Rodney Renberg did call roll, Michael Juica, Dick Hoffman, and Dutch Antonisse were present. Quorum was established. Chris Reed was absent.

Dick Hoffman made a motion to accept the Regular Meeting Minutes of 6/19/18 as presented, seconded by Dutch Antonisse. Motion carried unanimously.
