## Regular Council Meeting

### Agenda

- 1. Call to order by Mayor Miller @ 6:30 pm.
- 2. Pledge of Allegiance led by Councilman Scoggins.
- 3. Roll Call; Mayor Miller, Mayor Pro-Tem Spahlinger, Councilman Scoggins, Councilwoman Hanson, Councilman Rottino, Councilwoman Cuevas.
- 4. Councilwoman Hanson made a motion to approve Minutes: Regular Meeting 9/17/2024. Seconded by Councilwoman Cuevas. Motion carried 4/0.
- 5. Councilwoman Hanson made a motion to approve Consent Agenda Items "A" thru "E"; Monthly Activity Reports for September 2024 as presented: (A) Financial and Expenditure; (B) Police; (C) Municipal Court; (D) Streets: (E) Equipment. Seconded by Councilwoman Cuevas. Motion carried 4/0.

- 11. Councilwoman Hanson made a motion to approve Ordinance 2024-07 Amendment of Ordinance 1988-01-1 PSVFD. Seconded by Councilman Scoggins. Motion carried 5/0.
- 12. Councilwoman Hanson made a motion to approve Interlocal Agreement with Gun Barrel City regarding Housing Warrants. Seconded by Councilman Rottino. Motion carried 5/0.
- 13. Councilwoman Hanson made a motion to approve Purchase of Police Car with a limit of no more than \$20,000, and under 100,000 miles. Seconded by Councilwoman Cuevas. Motion carried 5/0.
- 14. Consider & Take Action to Award an administrator to assist the City with a 2025-2026 CDBG Community Application (Phase 1), Project Application (Phase 2) and Grant Implementation, if funded. This line item was postponed.
- 15. Councilwoman Cuevas made a motion to authorize the submission of an application to the Texas Department of Agriculture for the Texas Community Development Block Grant 2025-2026 Community Development Fund. Seconded by Councilwoman Hanson. Motion carried 5/0.
- 16. Councilwoman Hanson made a motion to approve Thanksgiving Luncheon for 11/19/2024 @ 11:00-1:00 with a spending limit of \$300.00 and catered by Vickys BBQ.

Should any final action, final decision or final vote be required in the opinion of the City Council with regard to any matter considered in such executive session, then the final action, final decision or final vote shall be in the open meeting covered by this Notice upon the reconvening of the public meeting.

"Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the citizens comment section of the meeting or at the time the agenda item is called for discussion by the mayor. Speakers must sign up with the City Secretary to speak and shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Criticism of city employees or staff is prohibited. Those wishing to address the Council regarding an item not on the agenda must be a citizen, property owner or business owner of Payne Springs. Comments on such non-agenda items shall be limited to three minutes. The Council will not comment on items not on the agenda; however, the Council may refer the item to city staff for research, resolution or referral of the matter to the Council as a future agenda item."
